

## Forest Echo Farm Pet Waiver and Release of Liability

Welcome to Forest Echo Farm! The following rules and guidelines have been put into place for the comfort of you, your pet, local wildlife, other visitors and Caretakers. We ask that you abide by these measures to keep everyone safe and comfortable during your stay.

### Our Policy

- Well-behaved dogs are welcome.
- Dogs must be under guest's control at all times when they are in any outside area on Forest Echo property.
- Dogs must be on a leash at the Farm Pond and in other common areas when other people are present.
- Guests are responsible for cleaning up after the dog in their cabin. Pay extra attention to dog hair on furniture and rugs.
- Guests will be responsible for any property damage and/or personal injury caused by their dog.
- Any disturbance by your dogs, such as barking, must be controlled at all times.
- Guests agree to indemnify and hold harmless Forest Echo Farm from all liability and damage suffered as a result of their dog.
  
- Forest Echo Farm retains the right to charge the guest with the cost of any and all damage caused by their pet.

### Our Guidelines

- Dogs should not be left alone in cabins, however if you choose to do so, we recommend they be crated. This will avoid any unpleasant surprises all around.

### As a guest of Forest Echo Farm, I agree to the following:

- I will pay for any and all repair costs from damage caused by my pet during my stay.
- In the event my pet is deemed unable to stay at Forest Echo Farm, I will make arrangements to board my pet for the remainder of my stay, at my sole expense. Should I choose to instead shorten my stay, I understand that I will be charged for my entire reservation.
- Should my pet be a cause of disturbance to other guests, I will be liable for the cost of any consideration given to those guests.
- Forest Echo Farm retains the right to refuse to accommodate and/or evict any dog that it determines, in its sole opinion, may create a hazard or disturb the quiet enjoyment of its visitors, Caretakers or owners of the property.

### Indemnification and Release

In consideration of Forest Echo Farm allowing my dog(s) to stay with me, I understand that I voluntarily agree that I will be solely responsible for my pet and for any loss, damages, or personal injuries (including death), caused by my dog(s). I release and agree to hold harmless, indemnify, and defend the owner(s) of Forest Echo Farm from any and all claims, lawsuits, actions, debts, bills, or judgments arising from or related to my dog's presence at Forest Echo Farm.

One adult in your party responsible for your dog(s) must sign this form. You may add more signatures on the other side of this form if necessary. This is a legal and binding agreement between the signatories and F.E.F. Inc, a Vermont corporation with principal place of business at 697 Tinney Road, Mt. Holly, VT, 05758.
